Flight 93 National Memorial The site of the crash of United Airlines Flight 93, which was hijacked in the September 11 attacks

Historic Pump House, where the 1892 Battle of Homestead occurred, one of the biggest events in U.S. Labor History. This plant provided steel for the Empire State Building, Chicago Sears Tower and the Golden Gate Bridge in San Francisco!

The Bost Building, former headquarters of the Amalgamated Association of Iron and Steel Workers who were locked out of Homestead Steel Works and were involved in the "1892 Battle of Homestead."

Carrie Blast Furnace Complex Towering 92 feet over the Monongahela River, Carrie Furnaces 6 and 7 are extremely rare examples of pre World War II iron-making technology.

Heinz Memorial Chapel. Renowned for its beautiful stained glass windows (some of the tallest in the world!) with 391 identifiable figures such as William Shakespeare and Florence Nightingale. Here we'll enjoy hearing some music on Heinz Memorial Chapel's powerful pipe organ.

Dinner at The Grand Concourse. A beautiful example of the creative reuse of space in the Pittsburgh region, the former Pittsburgh and Lake Erie Railroad Station by the Monongahela River now houses a world-class restaurant. Enjoy a fabulous evening in the historic Pittsburgh locale!

Duquesne Incline Enjoy a ride on a century-old funicular, one of the few left in the nation!

The Pennsylvania Trolley Museum which includes a Trolley Era intro video, a tour of the restoration shop with an opportunity to talk with restorers, then a ride on an actual trolley on a scenic (and narrated) four-mile roundtrip!

Lunch at Angelo's Restaurant, a family-owned Italian restaurant that's been serving the community over 70 years.
